Dear Mr. Martin:

I received your letter, dated April 23, 1990, concerning the expenditure of funds that the Hickory Tavern Youth and Recreation Association will receive from Laurens County. As you know, the Parks and Recreation Commission approved the allocation of \$2,000 to the Association on April 7, 1990.

Since I talked to you on the telephone recently, I have reviewed the County's Purchasing Policy. That policy requires that the County receive bids, prior to the expenditure of funds for projects.


To comply with this policy and for auditing purposes, I would recommend that the Association follow the procedures listed below:

1. The Association should obtain at least two bids from reputable vendors and submit these bids to the Council Office at your earliest convenience. If you are able to obtain one bid, that will be satisfactory, but I would appreciate it if you document this fact in writing.
2. Once the bids have been received, I will issue a letter immediately that will commit \$2,000 from Laurens County to proceed with the work.
3. Once the project is started, the contractor can submit the bills directly to the County Council Office and the County will pay the bills, up to \$2,000, on behalf of the Hickory Tavern Youth and Recreation Association.

I realize this process is involved. However, the process described above will protect the County certainly appreciates the efforts of the Association in providing recreational opportunities for the Hickory Tavern area.
